***This puppy is being sold on a NON-Breeding CKC registration. Under NO circumstances is this dog being purchased with the intention of being bred. If it is discovered that a breeding intentionally or unintentionally with this dog. This health guarantee will immediately be NULL AND VOID.***

## PART 1 – Conditions of Sale

1. This puppy has received his first shot along with, three (3) de-worming’s. A certified Veterinarian has also fully assessed the health of this puppy. A complete health record is attached, for the buyer’s information and review. The puppy must still receive two more boosters followed by a rabies vaccine by nine months old. The puppy must not receive two (2) vaccinations at the same veterinarian visit. If the buyer does not comply with the aforementioned conditions, the buyer herein acknowledges and agrees that this health guarantee is immediately rendered null and void.

1. The buyer acknowledges and agrees not to take the puppy to public places or to socialize with unvaccinated puppies until after the final vaccine has been given. If the buyer does not comply with the aforementioned conditions, the buyer herein acknowledges and agrees that this health guarantee is immediately rendered null and void.

2. The puppy has been Taste of the Wild Bison PUPPY. The seller believes this is a very high Quality food. It is agreed the buyer will change to a high quality food of their choice. Understanding the change is to be very slow and gradual.

3. The buyer understands that it is the best interest of the purchaser and the puppy to continue with the Pet Insurance that has been sent home at the time of purchase.
4. The buyer herein acknowledges that the puppy will be taken to a certified veterinarian for checkup within 5 business days of taking possession of the puppy. All costs are the sole financial responsibility of the buyer. The buyer also herein acknowledges and agrees to inform the seller, in writing, and in advance of any material veterinary procedure to be undertaken.

The buyer herein also acknowledges and agrees to inform the seller in writing, of any sign of illness manifested by the puppy as soon as it occurs. The buyer also herein acknowledges and agrees that the seller will not be responsible for any veterinary expenses incurred on behalf of the puppy without the seller's prior written acknowledgment and consent. The buyer herein acknowledges and agrees that if the puppy is not taken to a certified veterinarian, within 28 days this health guarantee is immediately considered null and void.

5. The buyer herein acknowledges and agrees that the buyer is fully cognizant of certain stress-related issues such as; giardia, demodex and coccidia including, but not necessarily limited to, worms, are common with a new puppy, and that the seller will not be responsible for any costs related to any of these types of veterinary treatments.

6. The buyer herein acknowledges and agrees that there is NO guarantee against Hypoglycemia, Coccidiosis, Parasites, including but not necessarily limited to all types of Mange and Viral or Bacterial Infections. There is NO guarantee for allergies. Some disorders are caused by the environment that the puppy is put in. Any disorders caused from its surroundings are not covered. The seller does not provide a Health Guarantee for any eye irritations or cherry eye.

7. The seller will NOT reimburse for treatment of fleas, ticks, that the puppy could acquire during the 72 hours that the puppy is no longer under the seller's care and control. This puppy has received Advantage treatment and, to the seller's knowledge, is free of fleas, ticks.

## **PART 2 – Health Guarantee**

1. The seller fully guarantees this puppy for two (2) years to be free of genetic defects. The following genetic illnesses will be subject to compensation if all procedures are followed:
  - a) Hip and Elbow Dysplasia
    - Severe case (must be life threatening or requiring pain medication or surgery)
    - as diagnosed by OFA or OVC. An OVC grade 3+ of OFA moderate to severely dysplastic is warranting for refund or puppy replacement (see below for procedure details)
  - b) Heart
    - Severe case (must be life threatening or requiring pain medication or surgery)
    - as diagnosed by OFA or OVC. An OVC grade 3+
2. All testing and examinations are the sole responsibility of the buyer. Should one of the above listed defects be found, the buyer has a choice from the following two options:
  - a) ½ refund of original purchase price of the puppy (shipping costs are not included in a refund, as they are an extra that we offer)
  - b) a replacement puppy will be offered if the refund is not taken. No replacement puppy will be offered. Due to
    - if you wish to return your puppy for a replacement to the seller, the seller will pay the costs involved in this process
    - The buyer acknowledges and agrees that a replacement puppy from the next available litter of our choice shall be placed with you
    - The buyer will be responsible for pick up or shipping costs of this new puppy

**\*This refund or replacement is only valid upon completing the following:**

**We require all veterinary conclusions from your own veterinarian plus another opinion from a secondary veterinarian of our choice. All records, x-rays, exams, conclusions, vet certificates etc. are to be forwarded to us here at JACIB Kennels immediately following the initial diagnosis.**

3. The hip and elbow guarantee shall be null and void if any of the following conditions apply:
  - 1) the puppy is determined to have been overweight at any time; and/or 2) not de-sexed at appropriate age; and/or 3) involved in a serious fall; and/or 4) has been hit by a car; and/or 5) allowed to go up and down stairs in excess, prior to one year of age; and/or 6) been physically injured. If the buyer does not comply with the above conditions the buyer herein acknowledges and agrees that the seller's health guarantee is immediately rendered null and void.

4. This puppy has been placed in the buyer's care, and the buyer shall maintain this puppy at a healthy weight and shall not over exercise or allow the puppy to go up or down stairs in excess for the first year of life, the puppy shall also complete at least one level of puppy school. The buyer is now the primary caregiver, and as such, shall agree to care for this puppy to the best of the buyer's abilities. If the buyer does not comply with the above conditions the buyer herein acknowledges and agrees that the seller's health guarantee is immediately rendered null and void.

**PART 3 – Non – Disparagement**

*1. You agree that you will not disparage or encourage others to disparage JACIB Kennels. *2. You agree not to disparage or denigrate JACIB Kennels orally or in writing, and that neither you nor anyone acting on your behalf will publish, post, or otherwise release any material in written or electronic format, make speeches, gain interviews, or make public statements that mentioned JACIB Kennels, its operations, clients, employees, products, or services without the prior written consent of JACIB Kennels.*

*This contract is a legal binding document between the buyer and the seller. Disregarding this contract will result in legal action being taken against the buyer. The buyer herein and acknowledges that if the seller sells this dog the health guarantee immediately renders null and void. The seller must be contacted immediately if this puppy needs to be re-homed for any reason so as to assist in finding him/him a proper home. If unforeseen problems arise and you can not keep the puppy, the seller will welcome the puppy back but the seller **will not** reimburse any monies. By signing this contract the buyer, agrees to abide by all of the terms and conditions listed above.*

# Vitamin C for Puppies

This page provides information on vitamin C for puppies - Is it necessary to supplement our puppies with vitamin C? Which form of vitamin C is best? What are the benefits of vitamin C to puppies? How about dosage? Read on to find out.

You may wonder if it is necessary to supplement puppies with vitamin C, since puppies can produce the vitamin in their bodies. True - but if a puppy is stressed or sick, their bodies' output of vitamin C can quickly be depleted. In fact, it has been found that stress, both physical (e.g. fever, infections, etc.) and emotional (e.g. stress caused by a change in the environment), is the best-known cause of vitamin C depletion in puppies.

In addition, it has been found that puppies supplemented with vitamin C have stronger immune systems and show greater resistance to disease, and a better ability to recover from illness or injuries.

## Benefits of Vitamin C to Puppies

Vitamin C is an antioxidant. It works with vitamin E and helps regenerate vitamin E, enhancing its antioxidant effect.

Vitamin C improves immune function by enhancing white blood cell function and activity. It also increases the blood levels of interferon (the body's natural antiviral and anti-cancer compound) and antibodies (proteins that destroy foreign material such as bacteria, viruses, and toxins).

In fact, many veterinarians (both conventional and holistic) now routinely include vitamin C in their treatment protocols for various illnesses, including [cancer](#), infections such as bladder and [urinary tract infections](#), respiratory infections (e.g. [kennel cough](#)), and others.

Some veterinarians also suggest giving pups vitamin C as a preventative and immune booster. For example, vitamin C can be given to puppies before and after vaccination, to feeble and old puppies, to pregnant and lactating puppies, and to those that have been exposed to contagious diseases.

Moreover, vitamin C maintains the health of collagen. Therefore, it is also helpful for puppies with [arthritis](#) and degenerative joint disease, [hip dysplasia](#), and spinal disorders.

## Which Form of Vitamin C is the Best?

If you need to supplement your puppy with vitamin C, the best form is the salt forms of vitamin C, known as mineral ascorbates (calcium ascorbate and sodium ascorbate).

Ascorbates are easily absorbed anywhere in the puppy's intestinal tract. They are also considered to be the most-gentle (buffered) forms of vitamin C and cause fewer side effects such as diarrhea or heartburn.

Calcium ascorbate is pH-neutral, and has a slightly bitter taste. It is widely considered to be able to give the best results in relieving symptoms of arthritis.

Sodium ascorbate is also pH-neutral. It has a slightly saline taste. According to Dr. Wendell Belfield (the leading advocate of using vitamin C supplements in puppies), sodium ascorbate is the most effective form of vitamin C for puppies.

## Dosage and Precautions

Since vitamin C is water soluble, excessive amount is excreted through the kidney. However, too much vitamin C will cause diarrhea in puppies especially if given in one dose. How much vitamin C to supplement depends on the individual puppy's lifestyle and health condition, as well as the puppy's tolerance level of vitamin C (i.e. the upper limit of vitamin C before the puppy develops diarrhea).

In his book *"Four Paws, Five Directions: A Guide to Chinese Medicine for Cats and Puppies"*, Cheryl Schwartz, DVM, suggests the following dosages for health maintenance:

- **Puppies and Small Puppies:** 250 mg daily
- **Medium-sized Puppies:** 500 mg daily
- **Large Puppies:** 750 mg daily
- **Senior Puppies:** 500-1,000 mg daily per 40-50 pounds of body weight

For specific health problems, she suggests:

- **Arthritis:** as high a dose as possible with diarrhea being the limiting factor, up to 5,000 mg/day.
- **Ear Infections:** 125 mg twice daily for small puppies; 250-500 mg twice daily for medium puppies; 500-1,000 mg twice daily for large puppies.
- **Teeth/Gum Diseases:** 125 mg twice daily for small puppies; 250 mg twice daily for medium puppies; 1,000 mg twice daily for large puppies.
- **Upper Respiratory Problems:** 125-500 mg twice daily for small puppies; 250-1,500 mg twice daily for medium puppies; 500-1,500 mg twice daily for large puppies.
- **Skin Allergies:** 125 mg twice daily for small puppies; 250-1,500 mg twice daily for medium puppies; 500-1,500 mg twice daily for large puppies.
- **Bladder and Urinary Tract Infections:** 125 mg twice daily for small puppies; 250 mg twice daily for medium puppies; 500 mg twice daily for large puppies.
- **As Immune Booster:** 500 mg twice daily for small puppies; up to 1,500 mg twice daily for medium puppies and large puppies.

If your puppy develops diarrhea, adjust down the dosage until the stools are firm again.

## Heat Stroke

Dogs and cats can't perspire and can only dispel heat by panting and through the pads of their feet. If you suspect heat stroke in your pet, seek veterinary attention immediately.

**Signs of heat stroke include** *(but are not limited to):*

-

- Body temperatures of 104-110F degrees
  - Excessive panting
  - Dark or bright red tongue and gums
  - Sticky or dry tongue and gums
  - Staggering
  - Stupor
  - Seizures
  - Bloody diarrhea or vomiting
  - Rapid heartbeat

**Note:** Short-nosed breeds such as Bulldogs, Pugs, etc., large heavy-coated breeds, and dogs with heart or respiratory problems are more at risk for heat stroke.

## Cooling Your Pet

- Find some shade. Get your pet out of the heat.
- Use cool water, not ice water, to cool your pet (very cold water will constrict the blood vessels and impede cooling).
- Place cool wet cloths on feet and around head.
- Offer ice cubes for the animal to lick.
- Contact your your veterinarian.
